ARTICLES OF INCORPORATION OF PAUL TRITEL, M.D., P.A.

ARTICLE I. NAME

The name of this corporation shall be PAUL TRITEL, M.D., P.A

ARTICLE II. COMMENCEMENT & DURATION

The commencement of this corporation's existence shall be at the time of the filing of these Articles of Incorporation by the FLORIDA DEPARTMENT OF STATE. This corporation's duration shall be perpetual.

ARTICLE III. PURPOSES, POWERS, & RIGHTS

ARTICLE VI. BOARD OF DIRECTORS
