We, the undersigned, hereby make, acknowledge and file these Articles for the purpose of forming a corporation under the laws of the State of Florida:

ARTICLE I

Name of Corporation

The name of the Corporation shall be 4-J SOUTHERN RANCH, INC.. The address is 1178 10th Lane, Vero Beach, Florida 32960.

ARTICLE II

Purpose of Business

The Corporation is organized for the purpose of engaging in any activity permitted under the laws of the United States or of this State.

ARTICLE III

Capital Stock


