For

Article VII Officers

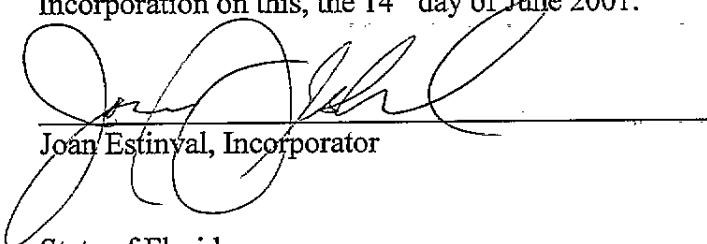
