THE UNDERSIGNED, acting as sole incorporator of **TJC MORTGAGE SERVICES, INC.** under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such Corporation:

ARTICLE I

Name

The name of the Corporation is TJC MORTGAGE SERVICES, INC.

ARTICLE II

Corporate Purposes, Power, and Rights

The purpose of the Corporation is to engage in any activity or business permitted under the laws of the United States and the State of Florida.

The corporation shall have two (2) director(s) who shall manage the corporation. The initial director(s) shall be:

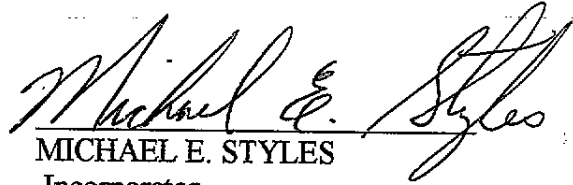
