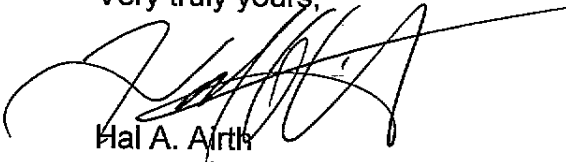

1. The above referenced for profit corporation was organized under the laws of the State of New Jersey on November 12, 1996.

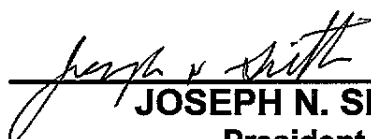

ARTICLE I

The name of this corporation is **THREE J & SMITH TRUCKING, INC.**

ARTICLE II

The corporation is to exist perpetually, commencing on the date of filing and recording of these Articles.

ARTICLE III

This corporation is organized for the purpose of freight hauling and any other legitimate business.

ARTICLE IV

This corporation is authorized to issue Two Thousand (2,000) shares of common stock having a par value of One Dollar (\$1.00) per share.

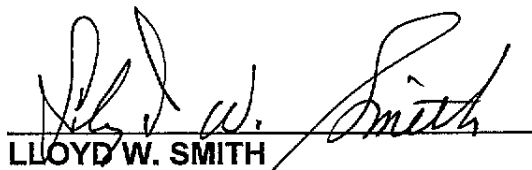
ARTICLE IX

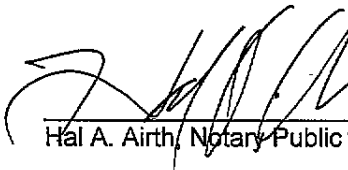

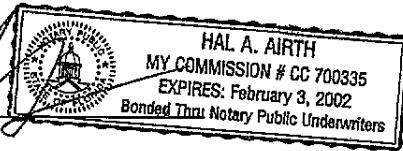

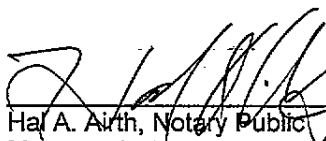
