ARTICLE I

The name of the corporation is COMS.I.T., INC. (the "Corporation").

ARTICLE II

The address of the principal office and the mailing address of the Corporation is 3784 38th Avenue North, St. Petersburg, Florida 33713.

This Corporation shall have authority to issue One Hundred Thousand (100,000) shares of Common Stock having a par value of \$0.01 per share.

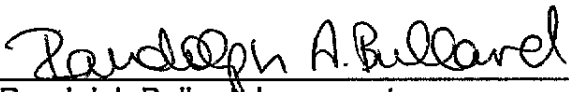
ARTICLE VI
