**ARTICLES OF INCORPORATION
OF**

The undersigned, desiring to organize a Corporation under Chapter 607, Florida Statutes, set forth the following:

ARTICLE I

The name of this Corporation shall be: **HOMEPORT, INC.**

The duration of the Corporation shall be perpetual.


