#### ARTICLE I

## Corporate Name and Principal Office

The name of this corporation is Savage Mojo, Inc. and its principal office and mailing address is 17324 Whirley Road, Lutz, Florida 33549.

#### ARTICLE II

## Commencement of Corporate Existence

The corporation shall come into existence upon the filing of these Articles with the Florida Department of State.

#### ARTICLE III

## General Nature of Business

This corporation may engage in any activity or business permitted under the laws of the United States or of the State of Florida.

#### ARTICLE IV

#### Capital Stock

The aggregate number of shares of capital stock that this corporation shall be authorized to have outstanding at any one time shall be fifty million shares of common stock at \$.000l par value per share.
