ARTICLES OF INCORPORATION

ARTICLE I. NAME AND ADDRESS. The name of this corporation shall be Bob Scotty Auto Rentals, Inc., and its principal office address is: 4917 N. University Drive, Ft. Lauderdale, FL 33351.

ARTICLE II. DURATION. This corporation is to exist perpetually.
