ARTICLES OF INCORPORATION OF MIA LAUDATO, INC.

ARTICLE I - NAME

The name of this corporation is MIA LAUDATO, INC.

ARTICLE II - DURATION

The period of its duration is perpetual, beginning from the date that these Articles are filed with the Department of State.
