WE, The undersigned, in order to form a Corporation for profit for the purpose hereinafter stated, under and pursuant to the provisions of the Florida Statutes, do hereby subscribe to this certificate of Incorporation, and do adopt the following Articles

ARTICLES OF INCORPORATION

of Incorporation:

ARTICLE I

The name of the Corporation shall be: AMERICAN BUSINESS PUBLICATIONS, INC.

The general nature of the business and the objects and purposes to be transacted and carried on by this Corporation shall be:
