ARTICLES OF INCORPORATION OF

In compliance with the requirements of F.S. Chapter 607, the undersized, seing a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the Corporation ("Corporation") is STEELE LOGISTICS SERVICES, INC.

ARTICLE II

The existence of the Corporation shall begin on June 20, 2001.

ARTICLE III

The street address of the principal office of the Corporation is 3131 St. Johns Bluff Road, Jacksonville, Florida 32246.

ARTICLE IV

The maximum number of shares this Corporation is authorized to issue is 5,000, par value \$.01 per share, all of which shall be Common Shares.
