OF**

ARTICLE I

NAME: The name of this corporation is: **CIMA RENT- A-CAR, INC.**

ARTICLE II

COMMENCEMENT OF EXISTENCE: This corporation shall commence to exist on the date filed with the Secretary of State.



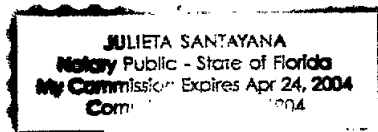
