ARTICLE I- NAME

SECRETARY OF STATE

The name of this corporation is Robert Smith irrigation Systems, Inc.

ARTICLE II- DURATION AND PRINCIPAL OFFICE

This corporation shall exist perpetually. The address and location for this corporation will be 206 Starfish Road, Mary Esther, FL., 32569

ARTICLE III - PURPOSE AND POWER

This corporation is organized to provide new irrigation Systems with subsequent maintenance and repair of same for residential & commercial properties. It will conduct this service within the state of Florida in accordance with the laws and statutes associated with this type of service


