
**ARTICLE X****ACTION BY DIRECTORS AND STOCKHOLDERS WITHOUT A MEETING**

**ARTICLE XI**

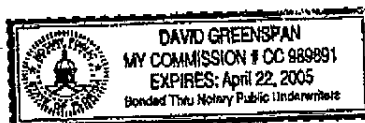
