ARTICLES OF INCORPORATION

The undersigned, acting as Incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

<u>ARTICLE I</u> <u>NAME</u>

The name of the Corporation shall be: Macias Fruit Harvesting, Inc.

ARTICLE II GENERAL NATURE OF BUSINESS
