ARTICLES OF INCORPORATION

OF

NATIVE SUN GUIDE SERVICE, INC

ARTICLE I. NAME

The name of this corporation shall be NATIVE SUN GUIDE SERVICE, INC.

ARTICLE II. COMMENCEMENT & DURATION

The commencement of this corporation's existence shall be at the time of the filing of these Articles Of Incorporation by the CHARLES EUGENE BUSBEE. This corporation's duration shall be perpetual.

ARTICLE III. PURPOSE

This corporation is being organized for the purpose of Fishing Guide and Charters engaging in the transaction of any and all business activities permitted under the laws of FLORIDA and the United States Of America.
