

ARTICLE I

NAME

The name of this Corporation is TARAMOR, INC.



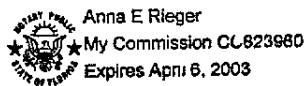


