ARTICLE I - NAME

The name of this corporation is CASH TO CLOSE, INC., whose principal office or mailing address is 207 Montego Inlet Blvd., Longwood, Florida 32779.

ARTICLE II - DURATION

As provided in Florida Statutes, Chapter 607, this corporation shall exist in perpetuity.
