## ARTICLES OF INCORPORATION OF PBS BROKERS, INC.

THE UNDERSIGNED, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

## ARTICLE I

The name of the corporation shall be PBS BROKERS, INC.

#### ARTICLE II COMMENCEMENT -- DURATION

Corporate existence shall commence JUNE 15, 2001. The duration of PBS BROKERS, INC. shall be perpetual.

#### ARTICLE III PURPOSE

The general purpose for which PBS BROKERS, INC. is organized are:

- A. To engage in business as a Sports Information Provider.
- B.
