**ARTICLES OF INCORPORATION  
OF

THE UNDERSIGNED, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

**ARTICLE I  
NAME**

The name of the corporation shall be GA INTERACTIVE, INC.

**ARTICLE II  
COMMENCEMENT - DURATION**

Corporate existence shall commence JUNE 15, 2001. The duration of GA INTERACTIVE, INC. shall be perpetual.

**ARTICLE III  
PURPOSE**

The general purpose for which GA INTERACTIVE, INC. is organized are:

- A. To engage in business as a Internet Content Provider.
- B. To transact any other lawful business for which corporations may be incorporated under the Florida General Corporation Act, or engage in any other trade or business which can, in the opinion of the Board of Directors of GA INTERACTIVE, INC. be advantageously carried on in connection with, or ancillary to, the foregoing business.
- C. To do such other things as are incidental to the foregoing of necessary or desirable in order to accomplish the foregoing.

**ARTICLE IV**  
**AUTHORIZED SHARES**

The aggregate number of shares which GA INTERACTIVE, INC. is authorized to issue is 10,000. Such shares shall be common stock of a single class and have a par value of one dollar (\$.0001) per share.

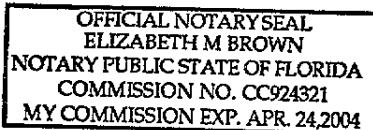
