ARTICLES OF INCORPORATION
OF A & A FAST FREIGHT, INC.

The undersigned, for the purposes of forming a corporation under the Florida Business Corporation Act, adopt the following articles of incorporation:

ARTICLE ONE

NAME

The name of the corporation is A & A Fast Freight, Inc..

ARTICLE TWO

PRINCIPLE OFFICE

The street address of the initial principal office of the corporation is 2423 Manatee Avenue West, Bradenton, Florida 34205.

ARTICLE THREE

CORPORATE DURATION

This Corporation shall commence corporate existence on the filing of these Articles of Incorporation and shall have perpetual existence unless sooner dissolved according to law.

ARTICLE FOUR

PURPOSE OR PURPOSES

The general purposes for which the corporation is organized are:

1. To be a brokerage firm between trucking companies and those who need goods transferred from one location to another.
2. AMENDMENTS

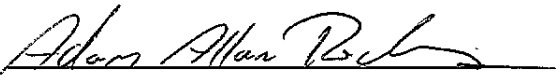

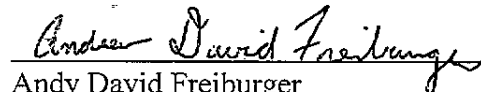
ARTICLE ELEVEN
