ARTICLE I - NAME

The name of the corporation shall be AZ Logistics Inc.. The principal place of business of this corporation shall be 9846 Portside Drive, Seminole, FL 33776

ARTICLE II - NATURE OF BUSINESS

This corporation may engage or transact in any or all lawful activities or business permitted under the laws of the United States, the State of Florida, or any other state, country, territory or nation.






