ARTICLES OF INCORPORATION OF SCHEFFER, INC.

THE UNDERSIGNED, acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation.

ARTICLE I-NAME

The name of this corporation is SCHEFFER, Inc.

ARTICLE II-EFFECTIVE DATE AND DURATION

The effective date of this corporation shall be upon the filing of these Articles of Incorporation with the Secretary of State and the duration of this corporation is perpetual.

ARTICLE III-PURPOSE

The purpose of this corporation is product development, farming and any other activity or business permitted under the laws of the United States and Florida.

ARTICLE IV-STOCK
