

Enclosed please find the Corporation Reinstatement Form for Wala Corporation, document number P01000062816 and the Articles of Amendment for Wala Corporation, document number P01000062816.

These forms are being sent because a reinstatement is necessary in order for this company to continue doing business, but the reinstatement will not be processed until the name of the corporation is changed to a name that is not already taken by another corporation. Wala Corporation, per the Articles of Amendment, will be changing its name to Wala 2 Corporation. This is being done to allow this company to continue to be registered with the same document number, P01000062816, it was originally registered under.
