does hereby form a corporation for profit under the laws of the State of Florida.

ARTICLE I.

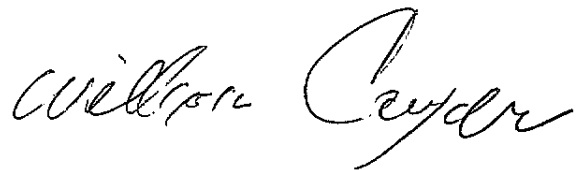
