ARTICLES OF INCORPORATION OF *EMS GROUP OF HOLLYWOOD, INC.*

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, adopt the following articles of incorporation:

ARTICLE ONE.

NAME

The name of the corporation is EMS GROUP OF HOLLYWOOD, INC.

ARTICLE TWO.

PRINCIPAL OFFICE

The street address of the initial principal office of the corporation is 1550 Weeping Willow Way, Hollywood, Florida 33019

ARTICLE THREE.

CORPORATE DURATION

The duration of the corporation is *perpetual*.

ARTICLE FOUR.

PURPOSE OF PURPOSES

The general purposes for which the corporation is organized are:

1. *To transact any other lawful business for which corporations may be incorporated under the Florida Business Corporation Act or engage in any other trade of business which can, in the opinion of the board of directors of the corporation, be advantageously carried on in connection with or auxiliary to the preceding business.*
2. To do such other things as are incidental to the above or necessary or desirable in order to accomplish as above.

ARTICLE FIVE.

CAPITALIZATION

The aggregate number of shares which the corporation is authorized to issue is Two Hundred Shares. Such shares shall be of a single class, and each share shall be par \$1.00.

ARTICLE SIX.

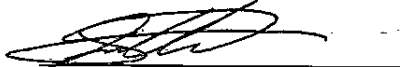
REGISTERED OFFICE AND AGENT

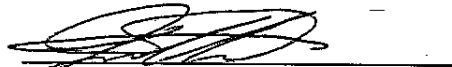
