ARTICLES OF INCORPORATION
OF
HOOLA, INC.

Article I- Name

The name of this corporation is **HOOLA, INC.**

Article II-Duration

This corporation shall exist into perpetuity unless sooner dissolved by law and commencing with the date of **filing of these Articles of Incorporation with the Department of State.**

Article III - Purpose

This corporation is organized for the purpose of transacting any and all lawful business under the laws of the United States and of the State of Florida.

Article IV - Capital Stock

This corporation is authorized to issue **7500 shares of \$1.00** par value common stock, which shall be designated "common stock."

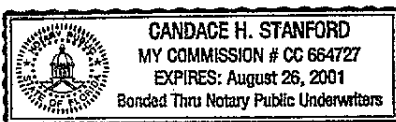


