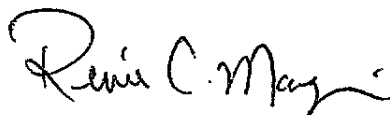

The undersigned incorporator, James T. Walker, hereby forms Wrangler Tractor Service, Inc., a corporation under Chapter 607 of the laws of the State of Florida.

ARTICLE I. NAME

The name of the corporation shall be:

This corporation is to exist perpetually.

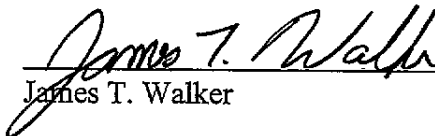
