The power to adopt, alter, amend or repeal bylaws shall be vested in the Board of Directors and the Shareholders.


ARTICLE IX**INDEMNIFICATION**

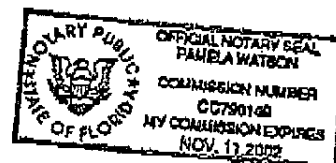
