The undersigned, for the purpose of forming a corporation under the logidassee, FLORIDA General Corporation Act, does hereby adopt the following Articles of

Incorporation:

ARTICLE !

The name of the proposed corporation shall be:

SUCCESS LANGUAGE ENTERPRISE, INC.

The general nature of the business and the object and purposes proposed to be

Transacted and carried on, are to do any and all things hereinafter

mentioned, as

fully and as to the same extent as natural persons might or could do, viz.:

A) To act as agent, broker, or managing agent for any person, firm, associations, corporations or companies. To further their business, to operate, manage, or conduct business on their behalf subject to a limitations prescribed

by the statues of the State of Florida:

- B) Generally to promote the LEARNING OR OTHER BUSINESS.

The corporation shall have perpetual existence.
