

ARTICLES OF INCORPORATION  
OF  
ACADEMY FOR CONTINUED ADVANCEMENT OF  
ATHLETICS & TRAINING, INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

Article I - Name

The name of the corporation shall be: ACADEMY FOR CONTINUED ADVANCEMENT OF ATHLETICS & TRAINING, INC.

Article II - Principal Office or Address

The principal place of business and mailing address of this corporation shall be: 157 E. New England Avenue, Suite 301, Winter Park, Florida 32789.

Article III - Shares

The number of shares of stock that this corporation is authorized to have outstanding at any one time is: One Hundred (100) shares of One Dollar (\$1.00) par value common stock, which shall be designated "Common Shares".


