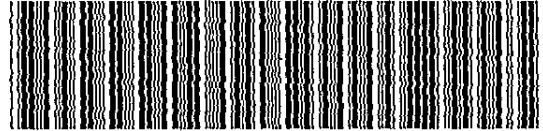

Effective date of dissolution is: June 1, 2005



FOURTH: No debt of the corporation remains unpaid.
