



**ARTICLES OF INCORPORATION
OF

ARTICLE I - NAME

The name of this corporation shall be LEVEL-FOUR BUILDERS, INC.

ARTICLE II - DURATION

The term of existence of the corporation shall be perpetual.

ARTICLE III - PURPOSE

The corporation is organized for the purpose of conducting any and all lawful business.

ARTICLE IV - CAPITAL STOCK




