ARTICLES OF INCORPORATION

In compliance with requirements of F. S. Chapter 607, the undersigned, being a natural person, hereby access an incorporator in adopting and filing the following Articles of Incorporation for the organizing a business corporation.

ARTICLE I

The name of the Corporation ("Corporation") is: **Hutchison Environmental Services, Inc.**

ARTICLE II

The existence of the corporation shall begin on the date these Articles of Incorporation are filed with the Secretary of State of the State of Florida.

ARTICLE III

The street address of the principal office of the corporation: 6101 College Parkway, Apartment 7F, Pensacola, Florida 32504.

ARTICLE IV

The maximum number of shares this corporation is authorized to issue is 100, par value one dollar per share, all of which shall be in shares.
