I have received your letter, copy attached, regarding the street address of Miami River Marine Village, Inc. (FEIN 65-1129994)

Please be advised that you already have the street address for Miami River Marine Village, Inc. It is 31 Garden Cove Drive, Key Largo, Florida. I believe I gave that to you when I registered the corporation. It is also my street address as Registered Agent for the Corporation, as it is for other corporations for which I am the registered agent.

However, just as your office does not get your mail delivered to a street address, neither does Miami River Marine Village, Inc. If you want the mail you send to Miami River Marine Village, Inc. to reach its intended recipient, including the Registered Agent, you should send it to the Post Office Box address I gave you in my annual report. I made it abundantly clear that the Post Office Box address is for mail and the street address is NOT FOR MAIL. I use mail that comes to the street address to line the cat pan.
