WE THE UNDERSIGNED, DO HEREBY ASSOCIATE OURSELVES TOGETHER AND SUBSCRIBE THIS CERTIFICATE OF INCORPORATION FOR THE PURPOSE OF FORMING A CORPORATION UNDER THE LAWS OF THE STATE OF FLORIDA, AND SUBJECT TO THE FOLLOWING PROVISIONS;

ARTICLE ONE

THE NAME OF THIS CORPORATION SHALL BE:

NATIONS BANKERS MORTGAGE CORPORATION

ARTICLE TWO

THE CORPORATION MAY ENGAGE IN ANY ACTIVITY OR BUSINESS PERMITTED UNDER THE LAWS OF THE UNITED STATES AND OF THE STATE OF FLORIDA.

#### ARTICLE THREE

THE MAXIMUM NUMBER OF SHARES OF STOCK WHICH THE CORPORATION SHALL HAVE OUTSTANDING AT ANY TIME, SHALL BE ONE THOUSAND (1,000) SHARES OF STOCK, WHICH SHALL BE COMMON STOCK OF A PAR VALUE OF FIFTY CENTS (\$0.50) OF A DOLLAR PER SHARE.
