

The undersigned subscriber to these Articles of Incorporation, being a natural person and competent to contract, hereby forms a corporation for profit under the laws of the State of Florida.

ARTICLE I. - NAME

Financial Planner Referral, Inc. is the name of this Corporation.

ARTICLE II. - PRINCIPAL OFFICE

The principal office of the corporation is 416 10<sup>th</sup> Avenue, NE, St. Petersburg, Florida 33701.

ARTICLE III. - DURATION

This Corporation shall have perpetual existence and shall commence on the date of filing of these articles.
