

ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF

MEDIFLEX TRAVELERS, INC.

Pursuant to provisions of Section 607.1001 and 607.1005 of the Florida Statutes, the undersigned Corporation adopts the following Articles of Amendment to its Articles of Incorporation.

- 1. The name of the Corporation is MEDIFLEX TRAVELERS, INC.
- The following amendment of the Articles of Incorporation was adopted by the Directors of the Corporation on August 7, 2002, in the manner prescribed by the Florida General Corporation Act.
- 3. The number of shares of the Corporation outstanding at the time of the adoption of this Amendment is zero and therefore the number of shares entitled to vote thereon is zero.
- 4. The amendment to the Articles of Incorporation of MEDIFLEX TRAVELERS, INC., is as follows:

Article III: Article III shall be amended as follows: The Corporation shall be authorized to issue a total of 7,500 shares of stock, of which 3,750 shares \$1.00 par value of common voting stock and 3,750 shares \$1.00 par value of common non-voting stock. The preferences, limitations and relative rights of the common stock is as follows:

Common voting stock shall only be entitled to receive dividends and/or profit sharing in accordance with Article VI of the By-laws of the Corporation; and

Common non-voting stock shall only be entitled to receive dividends and/or profit sharing in accordance with Article VI of the By-Laws of the Corporation.
