

OF

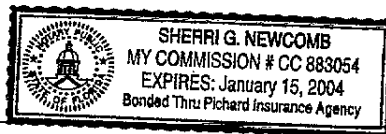
