# ARTICLES OF INCORPORATION OF Integrity Plus, Inc.

**THE UNDERSIGNED,** acting as sole incorporator of Integrity Plus, Inc. under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:

#### ARTICLE I

#### Name

The name of the corporation shall be Integrity Plus, Inc.

### ARTICLE II

#### Shares

The number of shares which the corporation shall have authority to issue is Ten Thousand (10,000), consisting of a single class of common stock, One Cent (\$0.01) par value per share.

#### ARTICLE III

#### **Principal Office**
