ARTICLES OF CORRECTION

OF

SPEECH SCIENCES, INC.


Speech Sciences, Inc., (hereinafter called the "corporation"), a corporation organized and existing under and by virtue of the General Corporation Law of the State of Florida, does hereby certify:

1. The name of the corporation is Speech Sciences, Inc.
2. The Articles of Incorporation of the corporation, which were filed by the Secretary of State of Florida on June 27, 2001, are hereby corrected.
3. The inaccuracy to be corrected in said instrument is as follows:
Article III incorrectly stated the number of authorized shares.
4. The portion of the instrument in corrected form is as follows:

ARTICLE III. CAPITAL STOCK

The maximum number of shares of stock the corporation is authorized to have outstanding at any one time is 20,000,000, all of which shall be classified as common stock and have a par value of \$0.01 each.
