OF

I, ROBERT BROADUS BROADWATER, being of legal age do hereby authorize
the formation of a corporation under the laws of the State of Florida.

ARTICLE I.

The name of this corporation shall be R. BROADWATER MONITORING, INC.

ARTICLE II:

This corporation shall exist perpetually unless sooner dissolved according to law.

ARTICLE III.

GENERAL NATURE OF BUSINESS

The general nature of business to be transacted by this corporation is to ensure the
following during on-site inspections and telephone contacts:

1. Activities performed by an approved clinical research site adhere to regulations set forth by the Food and Drug Administration to protect human research subjects
2. Activities performed by an approved clinical research site adhere to written protocol guidelines
3. Data produced by an approved clinical research site has been corroborated by source documentation.

4. To engage in any activity or business permitted under the laws of the United States of America and of the State of Florida.

ARTICLE IV.

CAPITAL STOCK

The maximum number of shares that this corporation is authorized to have outstanding at any one time is 100 shares fully paid, \$1.00 par value common stock. Common stock of the corporation shall be issued as "small business corporation" stock in accordance with a plan or plans under the provisions of Section 1244 of the Internal Revenue Code of 1954, as amended.

INITIAL DIRECTORS

The business of the corporation shall be managed by the Stockholders rather than by the Board of Directors of this corporation.
