We, the undersigned, as proper persons acting as incorporators of a corporation under the laws of the State of Florida, adopt the following articles of incorporation:

FIRST

The name of the corporation is Bettye A. Pfau, LCSW, P.A.

SECOND

The period of its duration is perpetual.

THIRD

The purpose is to engage in the following activities or businesses, as permitted under the laws of the United States and the State of Florida:

1. The practice of Clinical Social Work;
2. Design and creation of original handcrafted jewelry.

FOURTH

The aggregate number of authorized shares is one hundred (100).

FIFTH

The corporation will not commence business until at least \$100.00 dollars have been received by it as consideration for the issuance of shares.

SIXTH


