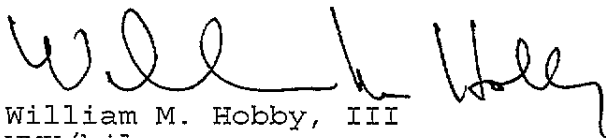

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

Article I - Name

The name of the corporation shall be: FIT FOR THE KING PRODUCTIONS UNLIMITED, INC.

Article II - Principal Office or Address

The principal place of business and mailing address of this corporation shall be: 405 Douglas Avenue, Suite 2505-3, Altamonte Springs, Florida 32714.

Article III - Shares

The number of shares of stock that this corporation is authorized to have outstanding at any one time is: Ten Thousand (10,000) shares of One Dollar (\$1.00) par value common stock, which shall be designated "Common Shares".

This corporation shall have perpetual existence unless dissolved according to law.

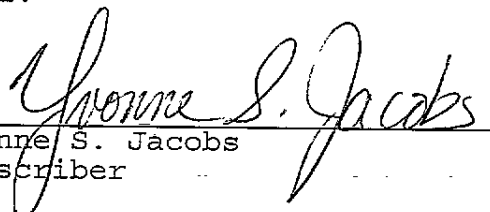
Article X - Action by Directors Without a Meeting
