The undersigned does hereby subscribe to, acknowledge and files the following Aracles Incorporation for the purpose of creating a corporation under the laws of the State of Floriday

## ARTICLE I - NAME

The name of this corporation is MIAMI IRONWORKS, INC.

# ARTICLE II - PURPOSE


