ARTICLES OF INCORPORATION

OF

ARTICLE I

NAME

The name of this Corporation is UNITED COMMUNITY CONSULTING CORP.

ARTICLE II

NATURE OF BUSINESS

This Corporation is being formed for the following purposes:

ARTICLETX

DIVIDENDS

Dividends payable in shares of any class may be paid to the holders of shares of any other class.

ARTICLE XI
