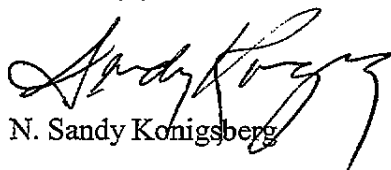

THE UNDERSIGNED subscriber(s) to these Articles of Incorporation, each a natural person, competent to contract, hereby associates themselves together to form a corporation for profit under the laws of the State of Florida; and further does agree to the following conditions of said corporation:

**ARTICLE I
NAME**

VERDUIN ENTERPRISES, INC.

**ARTICLE II
NATURE OF BUSINESS**

This corporation is organized for the following purpose or purposes: retail food restaurant establishment and transactions allowable under any and all applicable state and federal laws and all things related hereto and for the purpose of transacting any and all lawful business.

**ARTICLE III
CAPITAL STOCK**

This corporation is to exist perpetually.

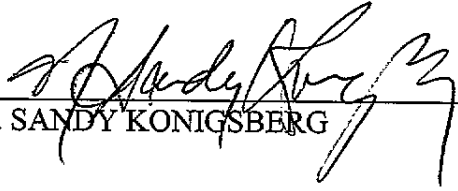
ARTICLE XI PREEMPTIVE RIGHTS

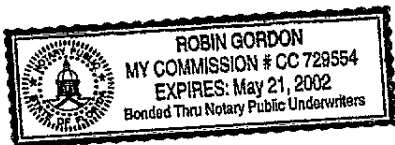
