ARTICLE I - NAME & ADDRESS OF THE CORPORATION

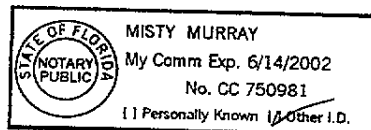


