ARTICLE I - CORPORATE NAME

The name of this Corporation is: S.K.C. OIL, INC.

ARTICLE II - NATURE OF BUSINESS AND POWERS

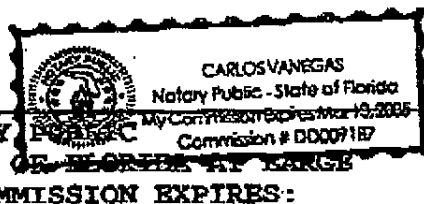
